

Application**Owner's Consent – Consent of the Owner of an Adjacent Private Property Crossed by the Connection Facility ("Crossed Property")****C2**

I, _____ the undersigned, as the owner of the property specified below, consent to the relevant electricity distribution network licensee installing a connection facility on my property as defined in Article 3(§ 6) of Law LXXXVI of 2007 on Electricity ("VET") (e.g., placing a connection distribution cabinet, running an overhead line, installing an underground cable, placing a pole).

I acknowledge that this consent is irrevocable and that it grants the electricity distribution network licensee an easement equivalent to a servitude, in favor of the electricity distribution network licensee, under Section 124 of the VET.

I acknowledge that based on this consent, the relevant electricity distribution network licensee is entitled to enter my property to operate, maintain, repair, modify, renovate, and develop the equipment placed on my property for these purposes, as well as to register the easement created by my consent in the land register.

If the property has multiple owners or usufructuaries, the majority consent of the affected individuals, based on their ownership shares (or in the case of usufruct, based on the rights burdening their ownership share), is required.
